Order Minimums

Order minimums may apply. Generally, order minimums are as follows:

- Breakfast: \$200.00 in food & beverage charges
- Lunch: \$200.00 in food & beverage charges
- Certain menu items may also require a minimum number of servings per item in addition to any other minimum charges

Note: Minimums may be reduced for regular clients. It is always our preference to build lasting relationships with clients so we can feel more comfortable accommodating a wider range of requests

Placing Orders & Reserving Services

- A minimum of 7 days' notice is preferred for Breakfast orders
- A minimum of 7 days' notice is preferred for Lunch orders
- Large-Scale events require a greater period of notice to accommodate additional planning & consultation
